Most data collected by SOBP are used only to help us better serve our members. It is our general policy to collect and store only personal information that our members and visitors knowingly provide. If our privacy policies change, we will notify all users by e-mail or a special announcement placed on the Web site.

The SOBP website uses cookies which are text files placed on your computer, to help SOBP analyze how users use the site. Information collected through cookies may be used for the purpose of evaluating your use of the website, compiling reports on website activity and providing other services relating to website activity and Internet usage. Cookies may also be used to help recognize you when you come back to our site and allow the site to populate the user name and password fields when you return to the site.

You may be allowed to use the website to register for the SOBP annual meeting or pay your annual membership dues. We use security measures such as encryption using Secure Sockets Layer (SSL) technology to protect the security of financial transactions. SOBP does not disclose credit card account information provided by its members and customers. When members and customers choose to pay using their credit cards, SOBP submits the information needed to obtain payment to the appropriate clearinghouse.
